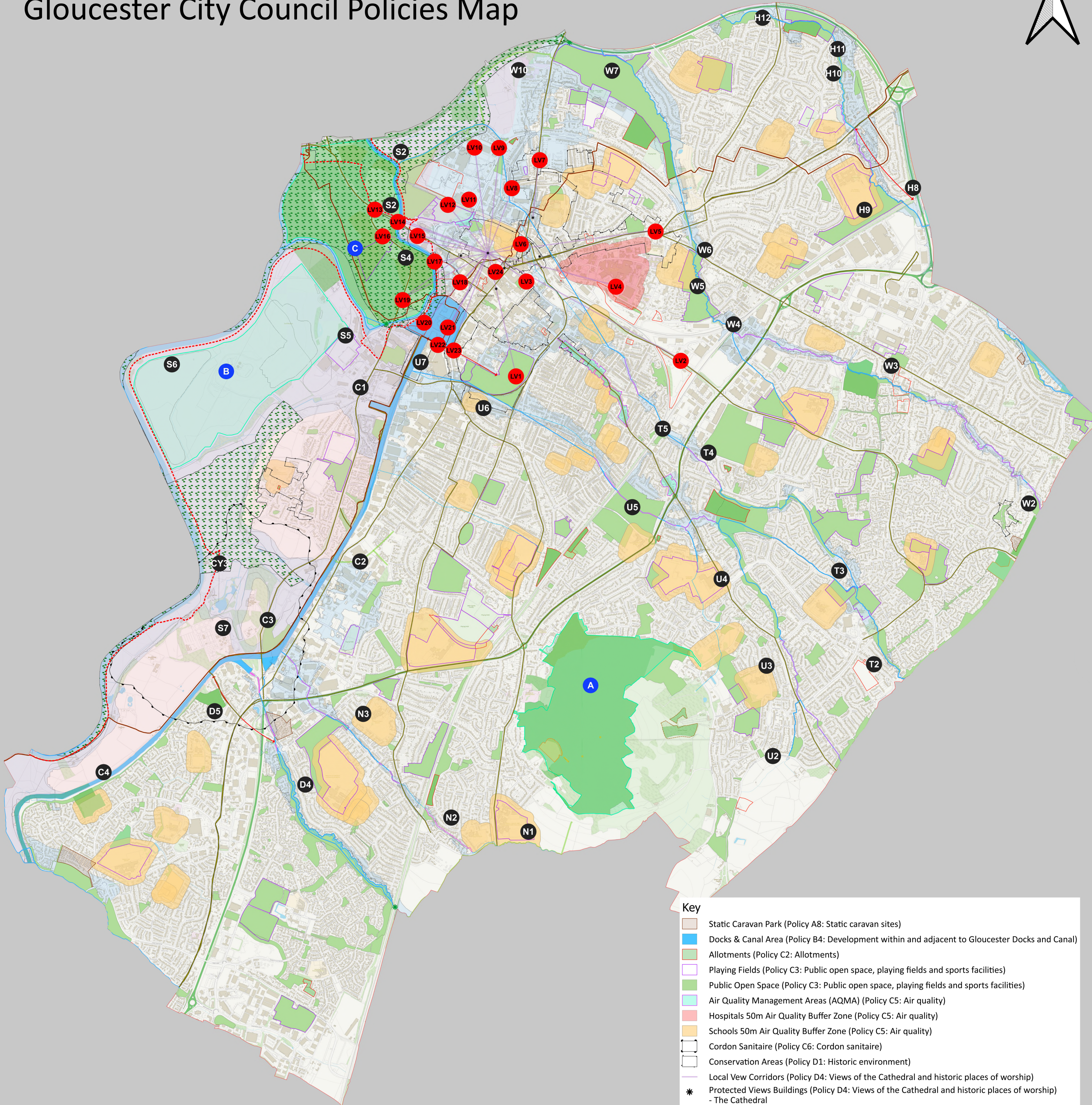


Gloucester City Council Policies Map
