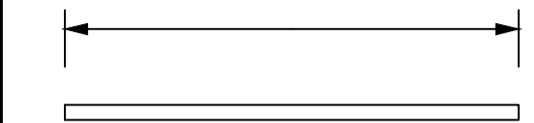

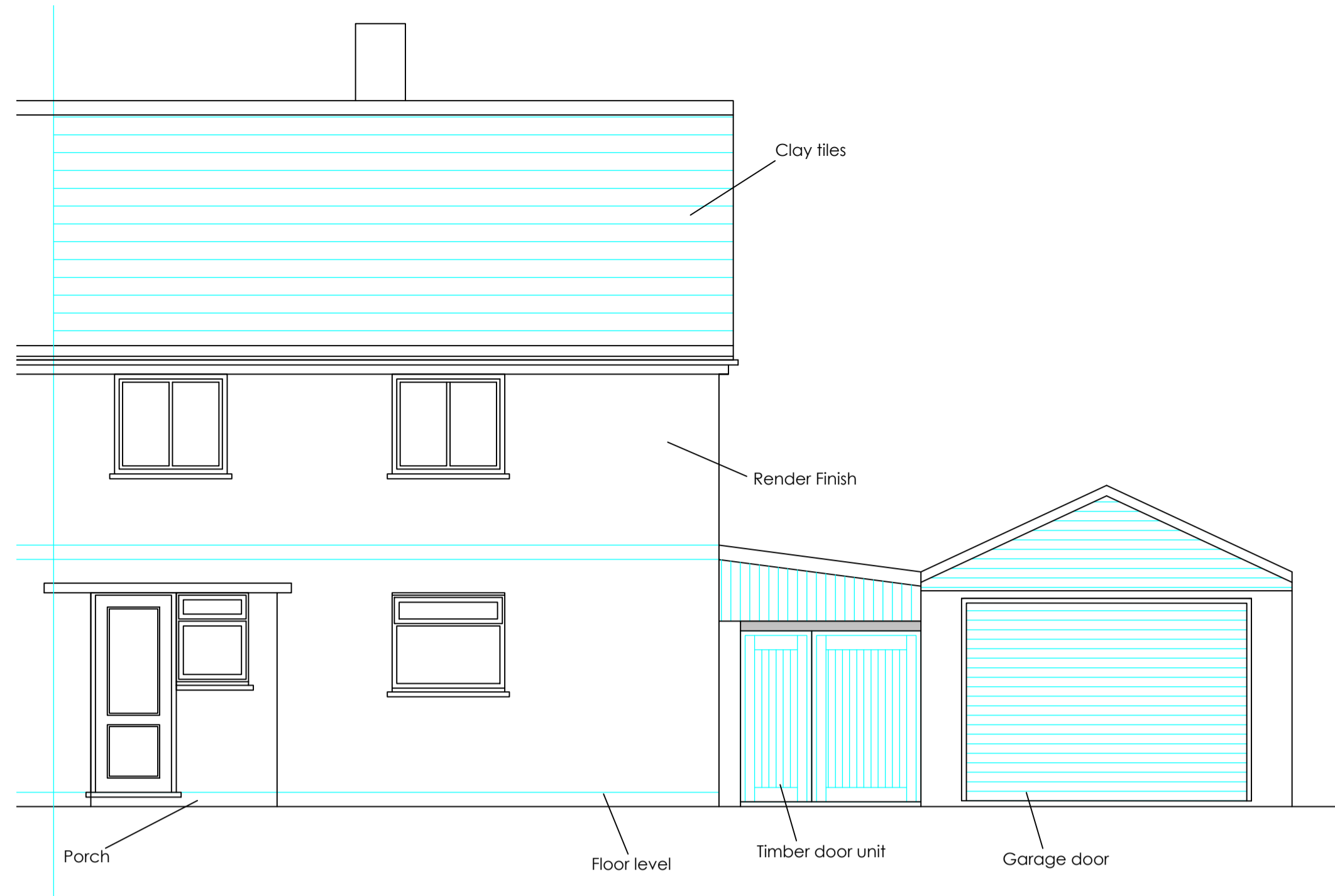

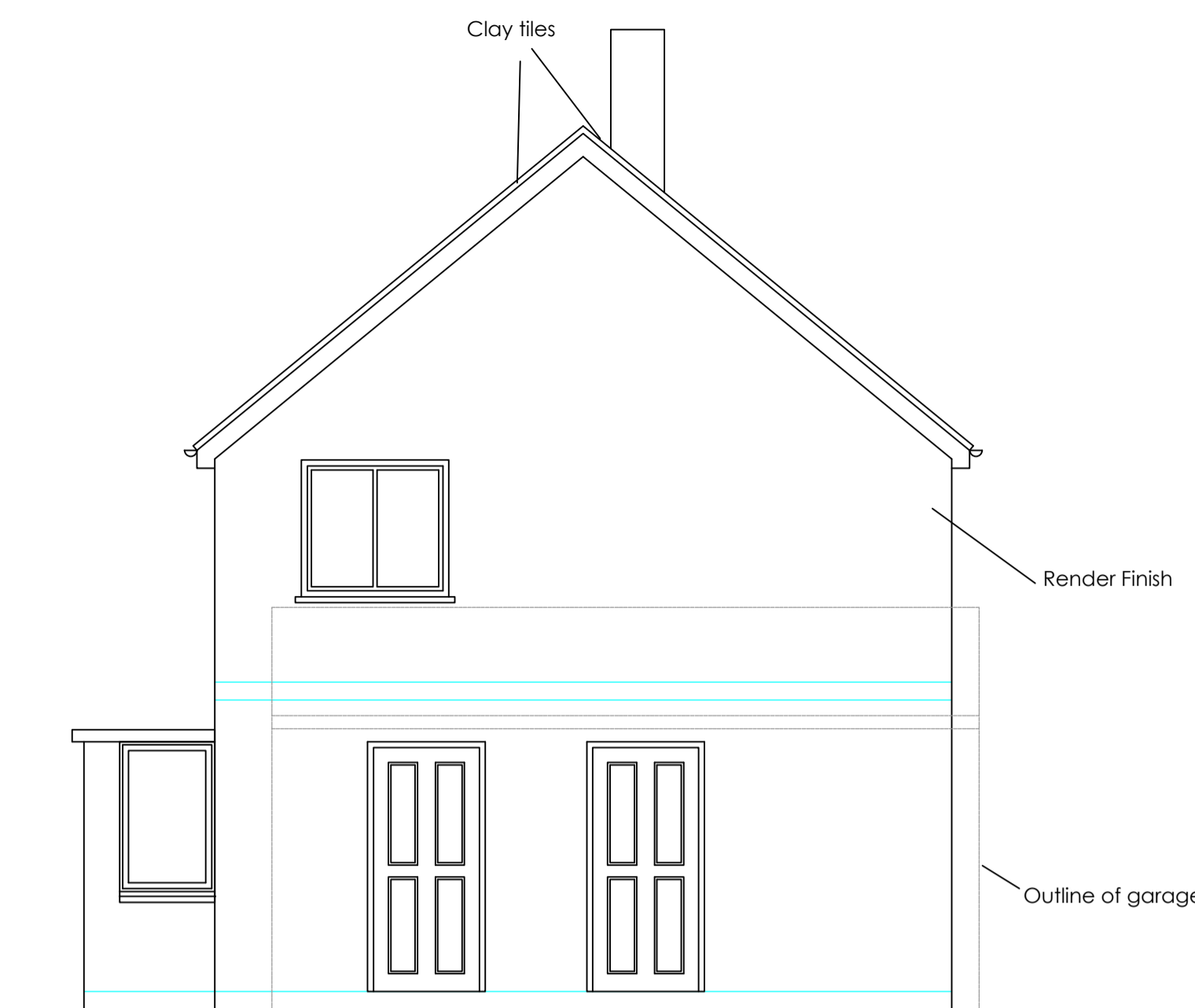

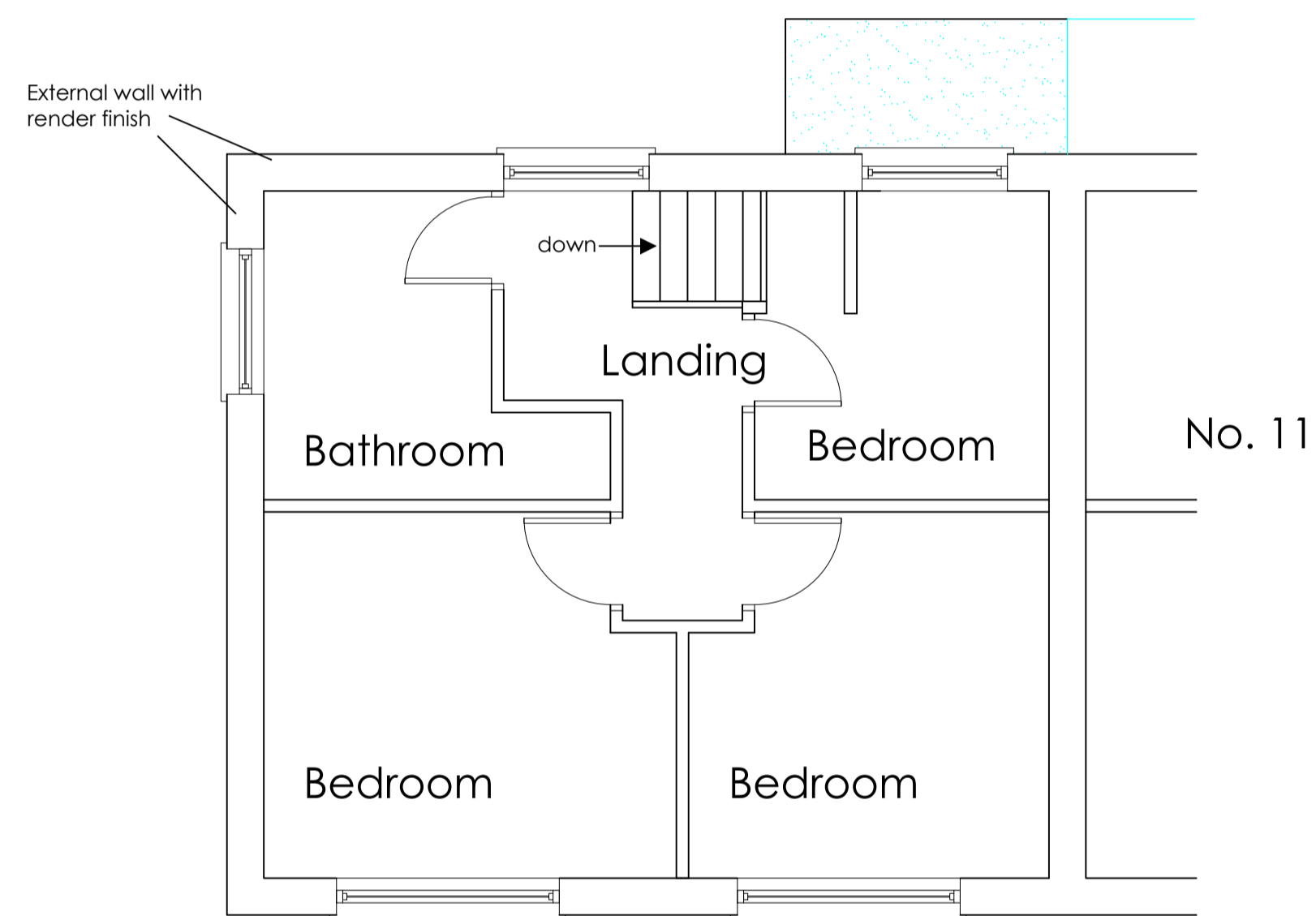
EXISTING FRONT ELEVATION 1:50



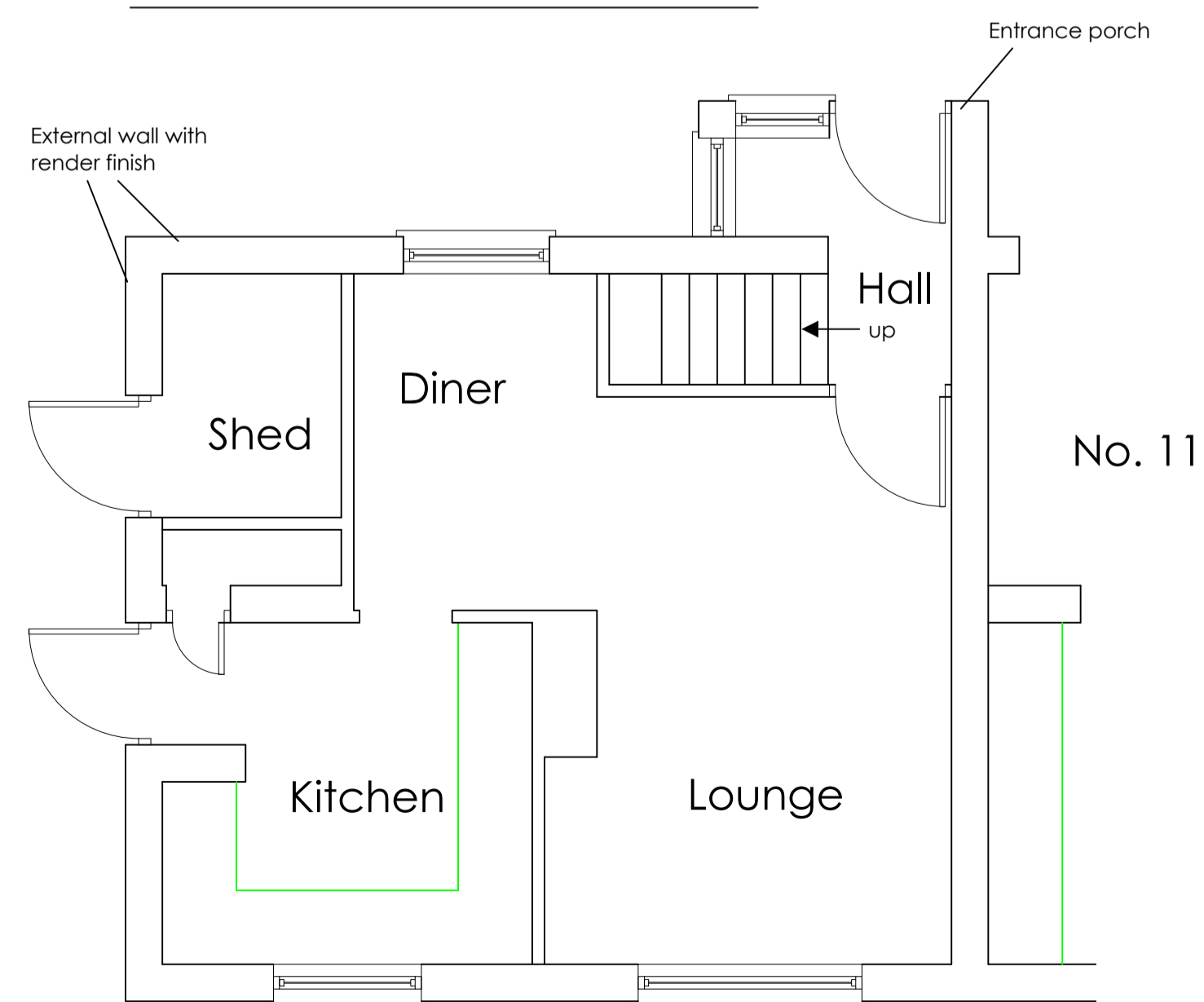
EXISTING SIDE ELEVATION 1:50



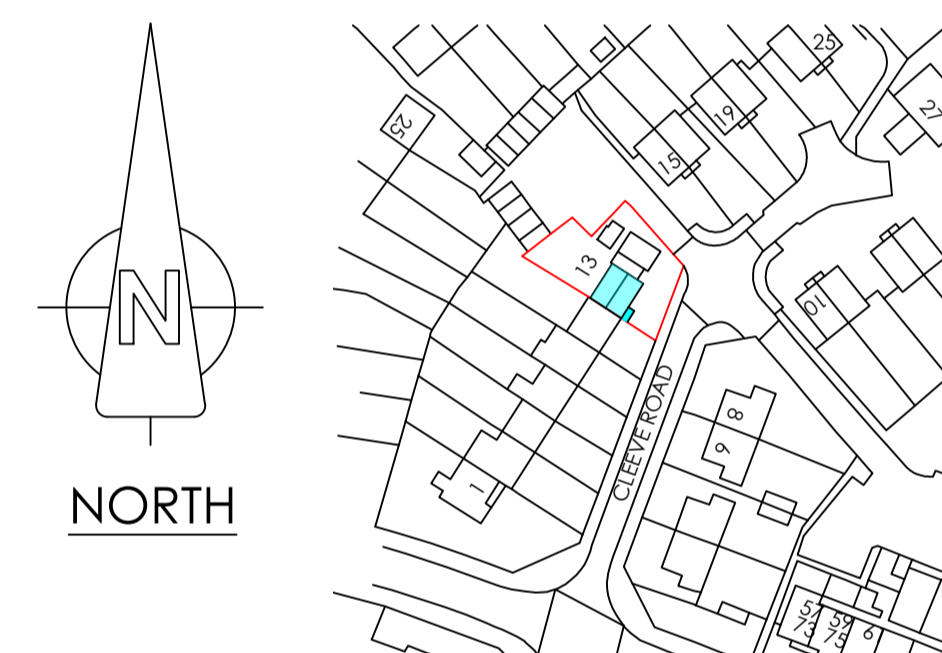
EXISTING REAR ELEVATION 1:50



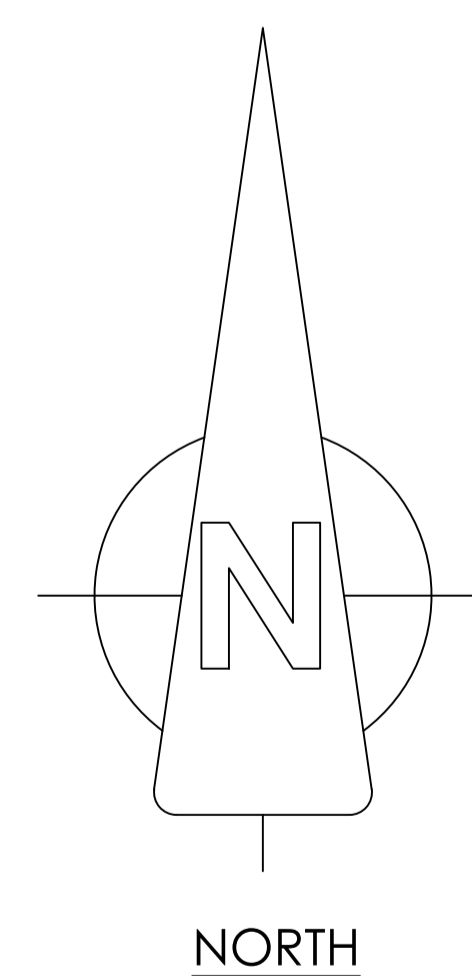
EXISTING FIRST FLOOR PLAN 1:50

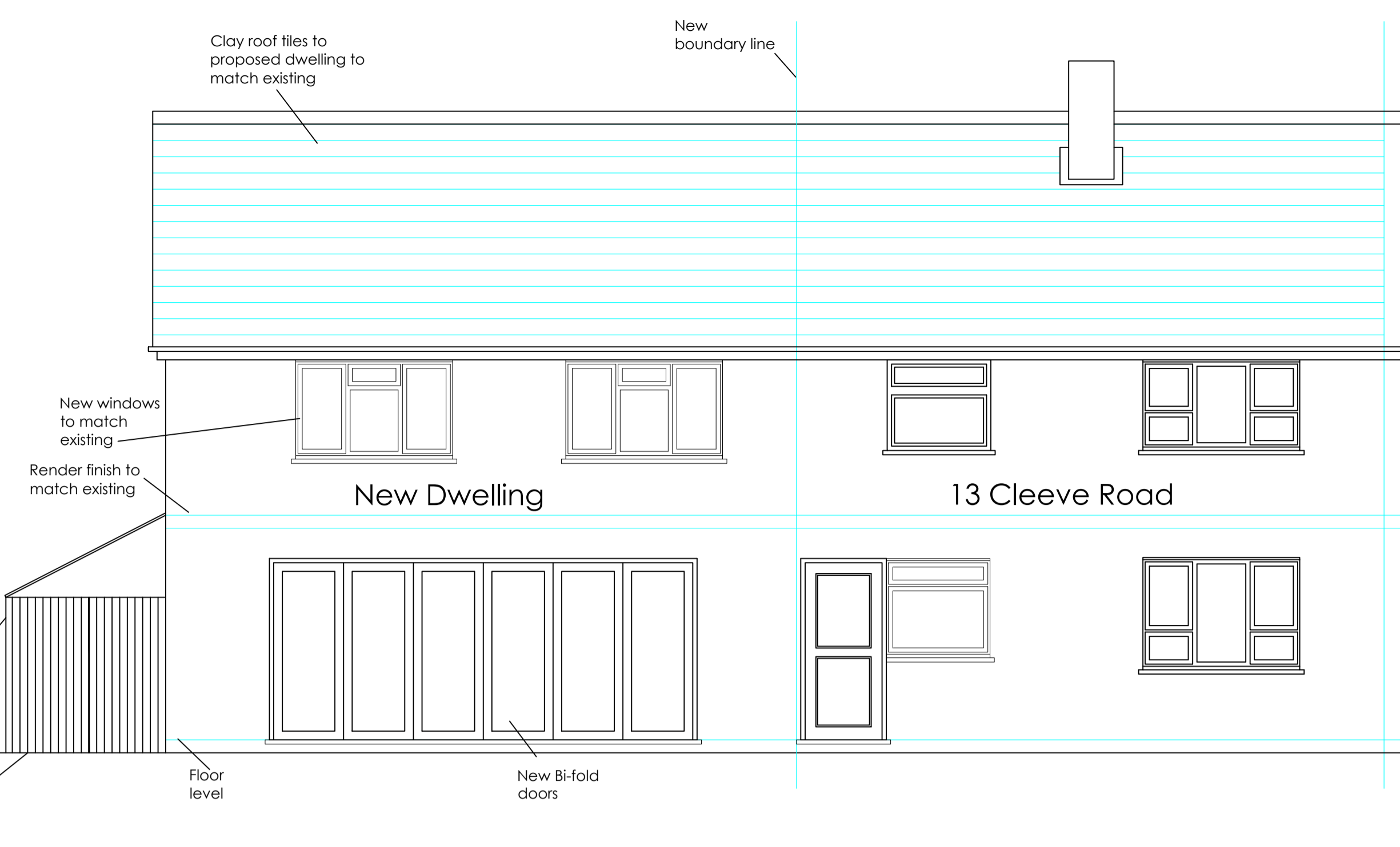

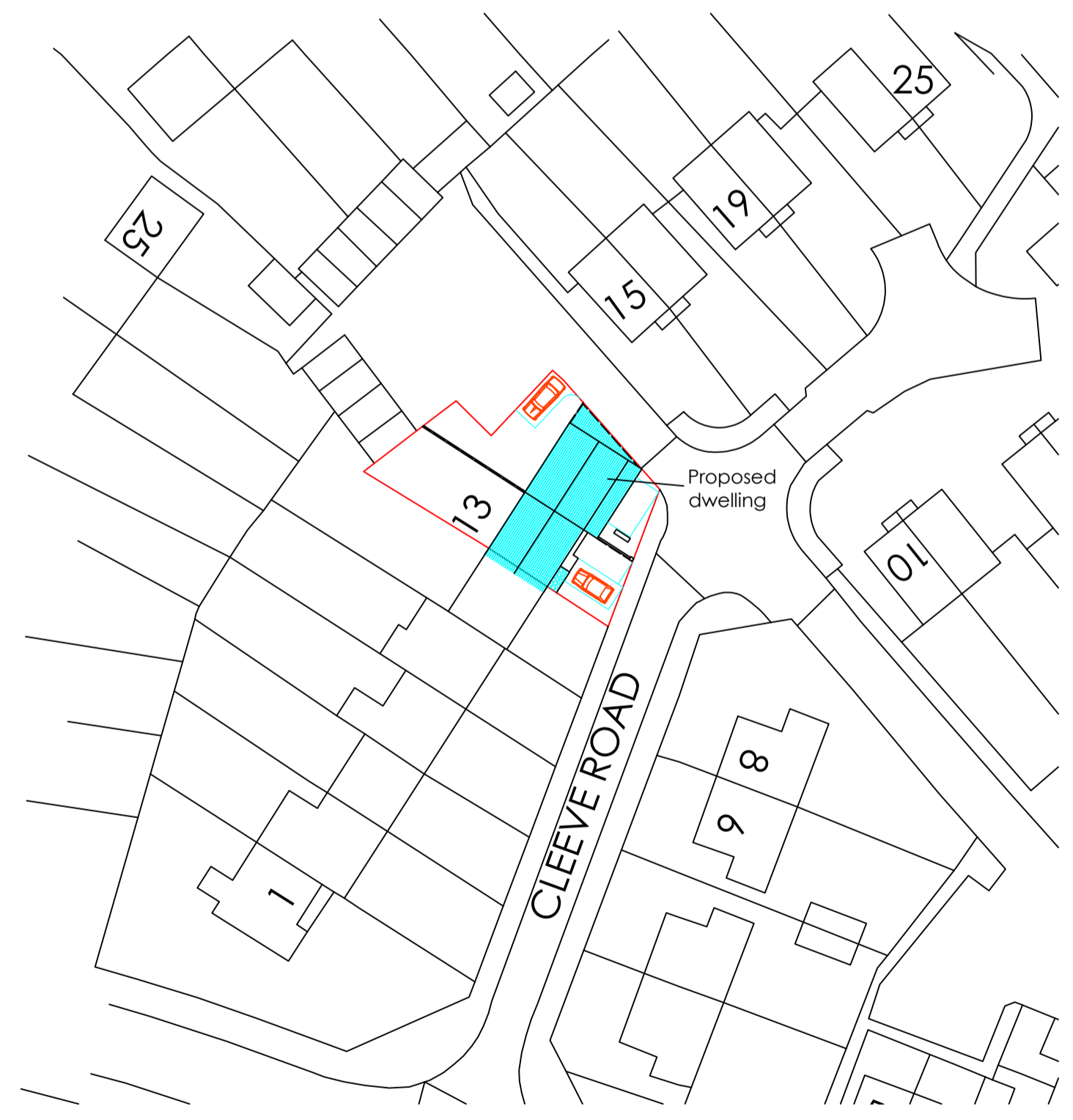
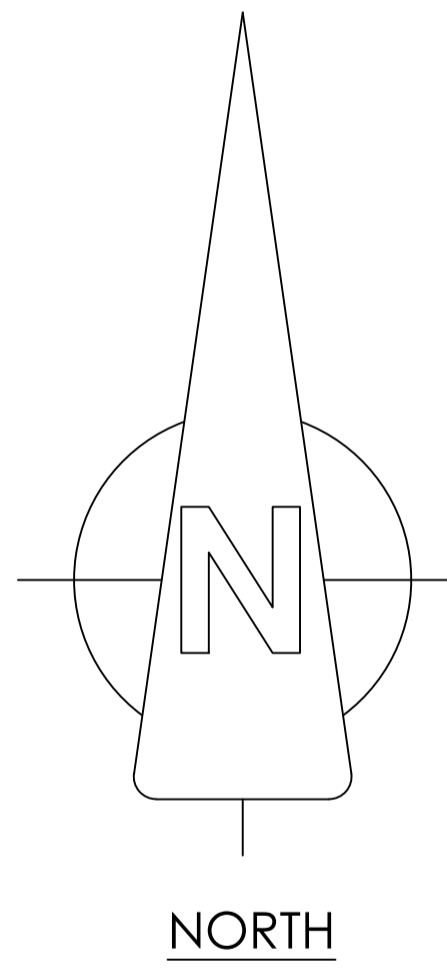

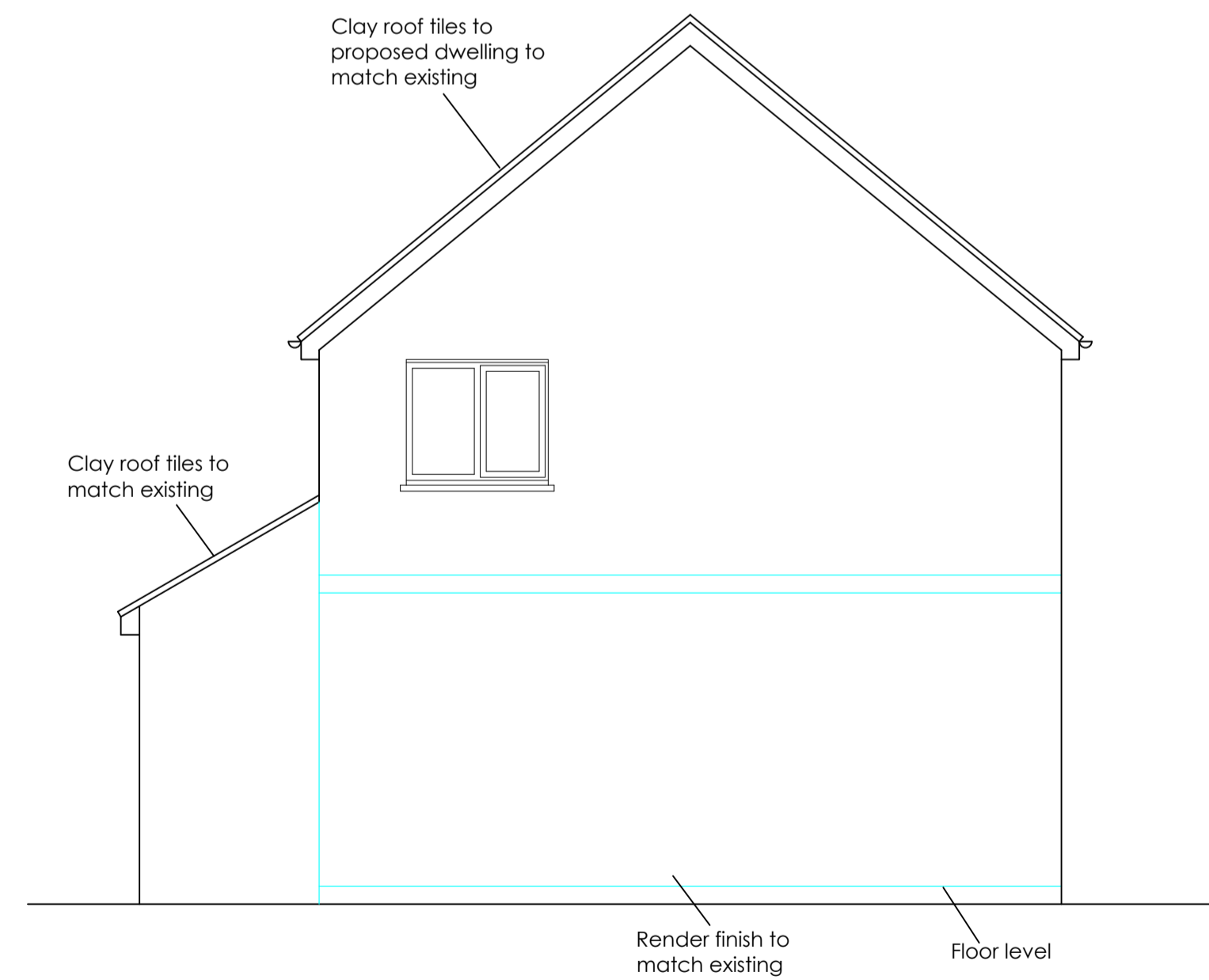
PROPOSED FRONT ELEVATION 1:50
