It may take up to 2 months to process a new application. Following receipt of a completed application, the Food and Licensing Team will consult with other consultation bodies that will also be notified and given 28 days to make representations. Most applications are determined within 6 weeks.

If you are selling alcohol or late night refreshment between 11pm and 5am you will also need to apply for a Premises Licence under the Licensing Act 2003.

Use of table and chairs or advertising boards on a highway will need a separate application to be made to the Licensing Team.
